2011 Membership Requirements

- Annual boat registration fees are \$1,500.00
 - OPTION #1 For \$1,500.00 you get your hull registration, OSS & APBA membership for 2 riding crew and 2 non-riding crewmembers. .
 - OPTION #2 \$500.00 per event for 3 events for hull registration and pay full OSS & APBA membership dues of \$300.00 each riding crew and \$100.00 per non-riding crew at the first event.
- Each race team will be required to make an appearance once per year at a location designated by a hosting race site. This will assist the local producers build a fan base for you in that community.
- Each race team will be required to make one appearance at every race in the Offshore Super Series Sponsor Midway entertainment area. A schedule will be sent two weeks prior to all races. Several teams will make appearances in the Sponsor Midway at the same time. Team promotional information can be passed out to spectators at that time.
- Proper execution of team membership bio sheets to be returned by deadline date. Photo for Series poster will be required.
- Appropriate team uniforms will be required to be worn at all Offshore Super Series Races, meetings, official functions and events.
- The applicant hereby grants permission to the Offshore Super Series Powerboat Racing Association and their sponsors to use photographs and media recordings made during a designated race for publicity and other non-commercial purposes.
- The applicant agrees to abide by all current OSS General and Technical rules, and their future revisions. These rules are part of this agreement.
